Dear Parents,

Registration for current students of St. Peter in Chains School will be held beginning January 28, 2018 and ending on Friday, February 16, 2018. Families whose registration forms and registration fees are received in the school office on or before Friday, February 2, 2018 will be eligible for a discounted non-refundable registration fee of \$ 50 for one student or \$ 100 for two or more students. Registration forms/fees received after February 2, 2018 will be assessed a fee of \$ 75 for one student and \$ 150 for two or more students.

The in-house registration **deadline is Friday, February 16, 2018**. After this date, your child's place will not be held if you have not returned all registration materials and payments. New families will be eligible to enroll their children after the in-house registration deadline.

Tuition rates are set by the parishes. In order to gather a more accurate account of enrollment figures and staff needs for the upcoming year, tuition rates are finalized and announced after the registration period has ended. However, we realize parents must budget for tuition. As a point of reference, the 2017-2018 tuition rate for one student is \$ 3,790.00 (includes parish subsidy/educational grant) and \$ 4,860.00 (without). Parishes require consistent attendance at Sunday Mass to qualify for the subsidy/grant.
